**ORDINANCE #23.2**

**Offenses Against Public and Private Property**

An ordinance of the Town of Bridge Creek, Eau Claire County, Wisconsin to create sections 23.02(1), 23.02(2) and 23.02(3) of the Municipal Code of the Town of Bridge Creek, Eau Claire County, Wisconsin relating to certain offenses against property.

**THE BOARD OF SUPERVISORS OF THE TOWN OF BRIDGE CREEK DOES  
HEREBY ORDAIN AS FOLLOWS:**

**Section 1**

**23.02(1) – Trespass to Land**

Wisconsin Statutes s. 943.13 regarding trespass to land, exclusive of penalty, is hereby adopted by reference along with any future amendments, revisions, or modifications, and made an offense punishable as a violation of this chapter.

Any person who violates this Section shall, upon conviction thereof, forfeit no less than \$200.00 and not more than \$350.00 together with the costs of prosecution shall be imprisoned in the county jail until said forfeitures and costs of prosecution are paid, but not exceeding 30 days. Each violation and each day a violation continues shall constitute a separate offense.

**Section 2**

**23.02(2) – Trespass to Dwellings**

Wisconsin Statutes s. 943.14 regarding trespass to dwellings, exclusive to penalty is hereby adopted by reference and made an offense punishable as a violation of this chapter.

Any person who violates this Section shall, upon conviction thereof, forfeit no less than \$300.00 and not more than \$500.00 together with the costs of prosecution and in default of payment of such forfeitures and costs of prosecution shall be imprisoned in the county jail until said forfeitures and costs of prosecution are paid, but no exceeding 30 days. Each violation and each day a violation continues shall constitute a separate offense.

**Section 3**

**23.2(3) – Trespass to Construction Sites and Other Locked Buildings**

Wisconsin Statutes s. 943.15 regarding entry onto a construction site or into a locked building, dwelling, or room, exclusive of penalty, is hereby adopted by reference and made an offense punishable as a violation of this chapter.

Any person who violates this Section shall, upon conviction thereof, forfeit no less than \$300.00 and not more than \$500.00 together with the costs of prosecution and in

default of payment of such forfeitures and costs of prosecution shall be imprisoned in the county jail until said forfeitures and costs of prosecution are paid, but not exceeding 30 days. Each violation and each day a violation continues shall constitute a separate offense.


**Section 4**

This ordinance shall be effective after adoption by the town of Bridge Creek Board of Supervisors and publication.


