

TOWN OF BRIDGE CREEK
Eau Claire County, Wisconsin

Resolution #10-21

WHEREAS, Wisconsin Statute Section 5.15 requires all cities, villages and towns with a population of 1,000 or more to establish wards based on the results of the 2021 census, and

WHEREAS, the 2021 census population for the Town of Bridge Creek is 2,164 and,

WHEREAS, continuity is to be considered in establishing wards favoring the general boundaries established in previous division of the town into wards, and

WHEREAS, a division of the town boundaries shall be reestablished into three wards which meet the statutory requirements for division and should be satisfactory considering possible population increases, and

WARD 1 – Consists of: All of that portion of the Town of Bridge Creek lying north of a line commencing at the intersection of County Road M and the town boundary; thence westerly along County Road M to its intersection with US Highway 12; thence northerly along US Highway 12 to the intersection of US Highway 12 and the City of Augusta boundary; thence northerly along the city boundary to its intersection with State Road 27; thence northerly along State Road 27 to its intersection with County Road V; thence easterly and southerly along County Road V to its intersection with the town boundary, and having a population of 894.

WARD 2 – Consists of: All of that portion of the Town of Bridge Creek commencing at the intersection of County Road M and the town boundary; thence westerly along County Road M to its intersection with US Highway 12; thence northerly along US Highway 12 to the intersection of US Highway 12 and the City of Augusta boundary; thence northerly along the city boundary to its intersection with State Road 27; thence northerly along State Road 27 to its intersection with County Road V; thence easterly and southerly along County Road V to its intersection with the town boundary; thence southerly along the town boundary to its intersection with Hilts Rd; thence easterly along Hilts Rd to its intersection with Livermore Rd; thence easterly along Livermore Rd to the intersection of Horton Rd.; thence continuing easterly on Horton Rd. to the intersection of Brunzil Rd; thence continuing east on Brunzil Rd to the intersection of County Road RR; thence easterly on County Rd RR to its intersection with the town boundary, thence northerly along the town boundary to the point of beginning, and having a population of 731.

WARD 3 – Consists of: All of that portion of the Town of Bridge Creek lying south of a line commencing at the intersection of the town boundary and Hilts Rd, thence easterly along Hilts Rd to its intersection with Livermore Rd; thence easterly along Livermore Rd to the intersection of Horton Rd; thence continuing easterly on Horton Rd. to the intersection of Brunzil Rd; thence continuing east on Brunzil Rd to the intersection of County Road RR; thence easterly on County Rd RR terminating at the intersection of County Road RR and the town boundary, and having a population of 539.

BE IT FURTHER RESOLVED, that a copy of this resolution be transmitted to the Eau Claire County Clerk within 5 days as required by SEC. 515(4) of the Wisconsin Statutes, and,

IT FURTHER RESOLVED, that the 3 wards of Bridge Creek will be combined for voting purposes and that the designated polls will be the Bridge Creek Town Hall for all three wards, unless subsequently changed by action of the Town Board.
