A Resolution to Request Eau Claire County to Enforce, Administer and Provide Inspection Services in the Town of Bridge Creek

WHEREAS, pursuant to Wis. Stats. Section 101.65 the Town of Bridge Creek has the authority to exercise jurisdiction over the construction and inspection of dwellings;

WHEREAS, Town Board for the Town of Bridge Creek has determined given the expertise, staffing and availability of resources that Eau Claire County is better able to provide enforcement and administration of the Wisconsin Uniform Dwelling Code in the Town of Bridge Creek than what could be provided by the Town Board;


WHEREAS, the Town Board of the Town of Bridge Creek has determined that it is in the best interests of the Town of Bridge Creek for Eau Claire County to enforce and administer Wisconsin Uniform Dwelling Code in the Town of Bridge Creek;

WHEREAS, the purpose of this Resolution is to request and delegate to Eau Claire County all enforcement and administration of the Wisconsin Uniform Dwelling Code in the Town of Bridge Creek as provided in Title 15, Buildings and Construction, Eau Claire County, Code of Ordinances.


NOW THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Bridge Creek, Eau Claire County, Wisconsin, at the November 21, 2019 Town Meeting did by majority vote authorize the Town Chairperson to request and delegate to Eau Claire County all enforcement and administration of the Wisconsin Uniform Dwelling Code in the Town of Bridge Creek as provided in Title 15, Buildings and Construction, Eau Claire County, Code of Ordinances.




